



# LEGAL DESCRIPTION

A PARCEL OF LAND BEING PART OF RIVER TRACT 59, OF THE MAUMEE AND WESTERN RESERVE LANDS IN TOWN ONE (1) OF THE UNITED STATES RESERVE OF THE TWELVE MILES SQUARE AT THE FOOT OF THE RAPIDS OF THE MIAMI OF LAKE ERIE IN THE CITY OF PERRYSBURG, WOOD COUNTY, OHIO, SAID PARCEL OF LAND BEING BOUNDED AND DESCRIBED AS FOLLOWS:

THENCE S00°31'42"E, ALONG THE WEST LINE OF SAID THE SANCTUARY PLAT SIX, PASSING THE SOUTH RIGHT-OF-WAY LINE OF SAID RESERVE DRIVE AT 60.03 FEET, A TOTAL DISTANCE OF 872.02 FEET TO A FOUND CONCRETE MONUMENT AT THE SOUTHWEST CORNER OF SAID THE SANCTUARY PLAT SIX. SAID POINT ALSO BEING ON THE NORTH LINE OF THE SANCTUARY PLAT FOUR AS RECORDED IN PLAT BOOK 22, PAGES 791 & 792, WOOD COUNTY, OHIO, PLAT RECORDS;

THENCE NOO'31'42"W. ALONG SAID EAST RIGHT-OF-WAY LINE AND NORTH LINE OF THE SANCTUARY PLAT FOUR A DISTANCE OF 7.14 FEET TO A FOUND CONCRETE

THENCE S89"28"18"W. CONTINUING ALONG SAID NORTH LINE OF THE SANCTUARY PLAT FOUR, PASSING THE WEST RIGHT-OF-WAY LINE OF SAID RESERVE DRIVE AT 60.00 FEET, A TOTAL DISTANCE OF 260.00 FEET TO A FOUND CONCRETE MONUMENT ON THE EASTERLY LINE OF LOT 161 AND THE NORTHWEST CORNER OF LOT 162 IN SAID THE SANCTUARY PLAT FOUR;

THENCE CONTINUING NOO'31'42"W, A DISTANCE OF 714.10 FEET TO A SET CONCRETE

THENCE NO2'23'13"W, A DISTANCE OF 308.67 FEET TO A FOUND CONCRETE MONUMENT IN THE SOUTHWEST CORNER OF THE SANCTUARY PLAT ONE AS RECORDED IN PLAT BOOK 21, PAGES 684 & 685, WOOD COUNTY, OHIO, PLAT RECORDS;

THENCE N89'28'25"E, ALONG THE SOUTH LINE OF SAID THE SANCTUARY PLAT ONE, A DISTANCE OF 539.58 FEET TO THE POINT OF BEGINNING.

CONTAINING 508,104 SQUARE FEET OR 11.665 ACRES OF LAND MORE OR LESS AND SUBJECT TO LEGAL HIGHWAYS, LEASES, DRAINAGE EASEMENTS, UTILITY EASEMENTS OR RESTRICTIONS OF RECORD AND ALL BEING WITHIN PARCEL NUMBER
