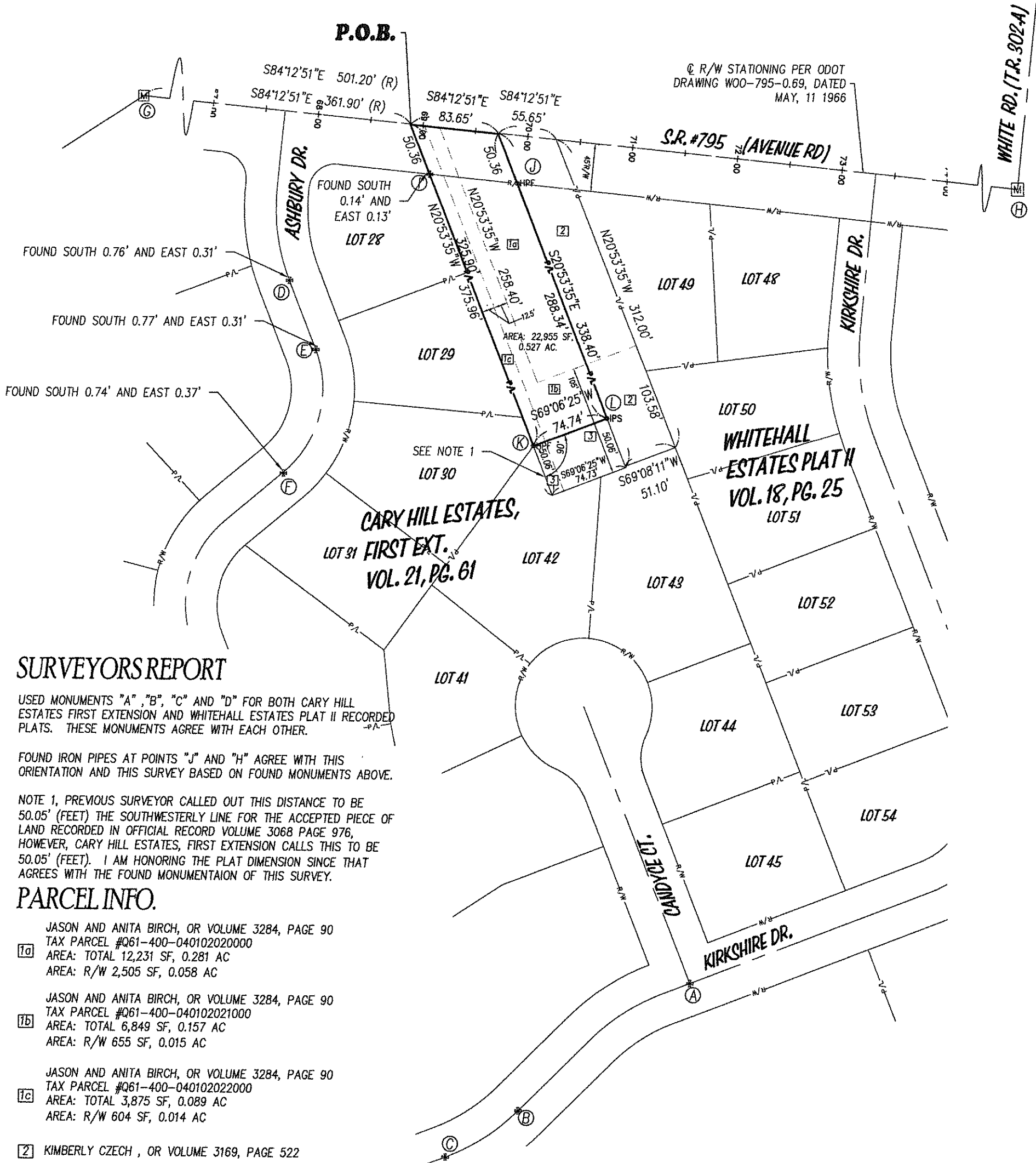

SURVEYORS REPORT

USED MONUMENTS "A", "B", "C" AND "D" FOR BOTH CARY HILL ESTATES FIRST EXTENSION AND WHITEHALL ESTATES PLAT II RECORDED PLATS. THESE MONUMENTS AGREE WITH EACH OTHER.

FOUND IRON PIPES AT POINTS "J" AND "H" AGREE WITH THIS ORIENTATION AND THIS SURVEY BASED ON FOUND MONUMENTS ABOVE.

NOTE 1, PREVIOUS SURVEYOR CALLED OUT THIS DISTANCE TO BE 50.05' (FEET) THE SOUTHWESTERLY LINE FOR THE ACCEPTED PIECE OF LAND RECORDED IN OFFICIAL RECORD VOLUME 3068 PAGE 976, HOWEVER, CARY HILL ESTATES, FIRST EXTENSION CALLS THIS TO BE 50.05' (FEET). I AM HONORING THE PLAT DIMENSION SINCE THAT AGREES WITH THE FOUND MONUMENTAION OF THIS SURVEY.

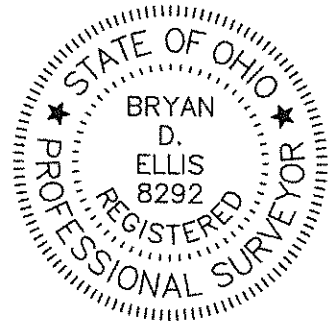
